Waiver of Liability and Informed Consent Release

Yayasan (Not-for-Profit) BSI International Clinics offers diagnoses and treatment of diseases that are based in virus, fungus, bacteria, cancer, and toxicity. We usually first detox the patient. We use and manufacture medicines and nutritional supplements that are made from plant and mineral sources, that may include treatments such as, skin ointments and salves, inhalation therapy, injection, IV infusion, surgery, oral medicine, nutraceuticals, oral tonics, supplements, vitamins, exercise, and nutritional counseling, etc.

As a sickness emerges, the body often 'appears' worse for a time, this is called The Herxheimer Effect (herxing, healing crisis). This is a sign the body is stronger and that the sickness is leaving. These are considered 'positive reactions' - signs the body is pushing-out parasites and disease, a 'worse appearance' usually means the therapy is working.

Natural healing often takes time. Modern medical practice gives instant results by suppressing the illness, causing the patient to rarely heal from the sickness, often making the sickness worse in years to come. However natural healing brings the sickness to the surface, allowing the body to heal

BSI offers a chance to detox and correct the problems that may have caused a disease, and this is often enough to cure a problem. The patients who do the best at BSI exercise regularly, get direct sunshine, follow exactly our diet and medical prescriptions, stop all stress and addictions, and get more than normal rest, drink much more water.

So as not to cause conflict with our prescriptions, we usually request the patient to stop most or all pharmaceuticals and addictions, bad foods, sometimes slowly to prevent shock.

During the period of treatment, normal reactions can arise such as nausea, vomiting, bruising, numbness, pain, abdominal bloating or pain, headache, diarrhea, rash, bleeding, dizziness, fainting, scarring, shaking, cold sweats, and although very rare, death is also a possibility, as it would be in any medical situation.

Knowing the above, with my desire for treatment with BSI International Clinic, then:

1. I agree to all the terms, procedures, and methods, that apply to my healing with BSI International Clinic.
(All therapies will be explained to and understood by me before proceeding.)
2. I understand that failure to provide truthful, accurate, and complete information to BSI, could result in termination of services.
3. I understand that if I miss one or more scheduled appointments, without notification to BSI, services are subject to permanent termination. I agree to arrive on time for all scheduled appointments.
4. I agree to undergo urine and blood tests related my care. I give authority to the BSI to view my medical records, including laboratory test results. I agree that BSI may keep copies of all medical records, in full confidentiality. BSI does not give nor sell personal information to anyone.
5. I agree to fully shut-off hand-phones, cameras, laptops, etc during a procedure or consultation.
The patient will be requested to leave electronics outside consultation and examination rooms.
6. I agree to respect the privacy and quiet of other patients, not talking on hand phones, or speaking loudly, when others are sleeping or resting while at BSI.
We request patients rest in quiet while receiving infusions.
7. **BSI does not provide emergency medical care.** If I unexpectedly require urgent medical assistance, then I agree to go immediately to the nearest hospital, and inform BSI of this action.
8. I understand that all medicines or therapies purchased at BSI International Clinic are not refundable (we cannot restock them once they have left our possession, due to unknown contamination).
9. I understand that BSI International Clinics can endorse insurance claims under most circumstances, provided the patient produces proper documentation.
10. I am willing to bear all the risks that may arise as a consequence of my treatment, and will not take any legal action against, nor slander BSI International Clinic or staff or associates, not will I ask for compensation.
